Doctors and Nurses Are Checking in on Senior Citizens in Hopes of Helping Them Stay Out of Nursing Homes

That is changing, however, and it could be carching on elsewhere.

Through a new program, partially supported by the federal Department of Housing and Urban Development, doctors and urse practitioners are visiting nany of the 109 residents at Vega Place, a government-subsidized apartment complex for senior citizens and people disabilities.

It's called the House Call program, said Ja'ner Huling, who dreamed up the idea, which has received a threeyear \$176,000 HUD gram.

Huling said the goal is to help people "to age in place longer and better."

Everyone benefits by keeping as many people as possible out of more expensive nutsing homes and hospitals.

Huling said many seniors don't get the care they need. Some-have trouble traveling or getting rides. They don't like the long wait at the county hospital and they don't like seeing a different doctor each time.

"It's a problem of access," said Dr. Ray Lewis, a Fort Worth geriatric specialist who will oversee the house calls at Vega Place.

Lewis said preventative medicine always is better and less expensive.

"If we can keep people out of nursing homes and hospitals, it can have a positive effect on the entire health system," Lewis said.


"The House Calls program is not a HUD program. However, we think it is a great idea and would like to see it duplicated in other projects for the elderly and disabled," said Patricia Campbell, a HUD spokeswormen.

"This really was Ja'net's idea. Many of the residents there don't have transportation and this could be a real benefit to them," Campbell said.

Huling said the word is getting out and managers of similar apartment facilities have begun contacting her to find out how they might do something similar.

She said about 90 percent of the residents at Vega Place will qualify for house calls.

Remember the good old days when doctors often made house calls? Well, for some residents of Fort Worth's Vega Place Senior Apartments, the good old days are back. Through a program called House Calls, doctors and nurse practitioners are visiting many of the 104 residents at Vega Place, a U.S. Department of Housing and Urban Development (HUD) subsidized apartment community for senior citizens and people with disabilities. Primary medical services can now be offered in the convenience of the patient's home.


After being awarded a three-year Service Coordination Grant from HUD totaling \$176,000, Ja'net Huling, then Vega Place property manager, began considering better ways to meet the medical needs of residents who were often unable to visit their doctors regularly. After becoming the service coordinator for Vega Place, she formed a unique partnership with a local health care provider, Health Essentials Solutions, Inc., and literally brought the House Calls program in-house. Approximately 90 percent of residents at Vega Place qualify for House Calls.

The kick-off ceremony held March 26 included residents, friends, local health care providers and other community leaders. Health Essentials' Marcey Gage told the audience, "Health Essentials is excited and looking forward to working with Vega Place seniors, and we thank HUD for the opportunity to work hand-in-hand to provide consistent and quality care to their residents."

E. Ross Burton, the HUD Region VI Multifamily Housing Hub Director, said that the goal of service coordination is to provide services residents need, such as health care, and ultimately help them avoid unnecessary institutionalization and improve their quality of life. Dr. Ray Lewis, a prominent Fort Worth geriatric specialist who will be overseeing the program, explained why preventive medicine is always better and less expensive. "If we can keep people out of nursing homes and hospitals, it can have a positive effect on the entire health system," Lewis said. Vergle M. Shreveport Opens Access To Empowerment Neighborhood Learning Centers



Manager Conquers Seniors Fears of Surfing

Fort Worth, TX--"Two and a half years ago, most senior citizens here had never touched a computer. They were totally opposed to bringing 'those machines' or a Maighborhood Notworks center here, recalls Ja'net Huling, manager of Vega Place Senior Apartments in Forth Worth, Texas. "It took me over a year to convince residents that computers could bring them lots of benefits--like Internet access to less costly prescriptions. Not only have residents overcome rejuctance about using computers, they are really enthusiastic about all the possibilities that computers and the Internet open up to them."

How did Huling change attitudes? "At our monthly resident meetings, I would bring up a computer-related topic, like using the Internet to find better deals on prescriptions." Once people understood this, they realized that it would be worth learning some basic computer skills to be able to explore different Web sites. Gradually, she won converts and 100 percent of the residents supported opening a Neighborhood Networks Center at Vega Place. "Residents really like living here, and the center has made life even better."

One of Huling's first activities at the center was helping eligible residents complete online applications for food stamps. "Mistakenly thinking the subsidy was only \$10 per month, many seniors had not bothered to enroll." She not only gave everyone more accurate information about this Federal program but also has helped 50 residents sign up for food stamps. Although the center will not have Internet access until next month, Huling used her own computer and Internet provider for this initiative.

Working with Tresa Echols, resident association president, Huling continues forming community partnerships to provide direct services at the center. Mondays through Saturdays, volunteers from Southwood Baptist Church are teaching residents to use computers. The Fort Worth Health Department conducts a Chronic Illness Management class that teaches residents how to manage their ailments and understand their necessary medications. Residents started a walking club as a result of this class. Another partnership is in the works with an organization that provides doctors who make house calls.

When California Commercial Investment Company bought Vega Place Senior Apartments in May 2000, the apartment complex was failing in most major categories of HUD's Real Estate Assessment Center's (REAC's) property inspection process. However, the new owner had a brighter vision for the apartments and invested a significant amount of capital in upgrades, including the Vega Place Center. It includes a comfortable and beautifully decorated community room and a computer center equipped with four stand-alone computers, two laptops, a printer, a scanner, and a digital camera, most of which were donated by HUD's Fort Worth office. Moreover, it has a clothes-care center and a clubroom, which the Vega Place Food Bank transforms into a grocery store the first and third Tuesday of each month. The Tarrant County Area Food Bank, Kroger Food Stores, and other groups donate the food, so residents shop for free.

Built on a wooded site ringed by mature pine trees, Cornerstone Gardens is a new addition to HUD's Section 202 assisted housing program inventory in Houston.



NONPROFIT DEDICATES SIXTH SENIOR COMPLEX in NYC

Selfhelp Community Services and its sister organization, United Help, Inc., hosted a dedication ceremony of a new Section 202 project on September 18. The Harry and Jeanette Weinberg Section 202 project is located in Queens, New York and is the sixth senior apartment building sponsored and developed by this nonprofit organization, providing housing to more than a thousand low and moderate-income seniors in New York City. Selfhelp's original and ongoing commitment to victims of Nazi persecution has expanded to include home- and community-based services to the elderly and others at risk of losing independence and dignity.

This new Section 202 property is the latest addition to a campus setting, joining two other senior housing developments and the Selfhelp Benjamin Rosenthal Senior Center. Construction was made possible by the nearly \$8 million dollars received from HUD in capital advance funds. Additional funding obtained from the Harry and Jeanette Weinberg Foundation enabled Selfhelp to provide enhancements to the building and to expand this supportive urban campus.

The 70 apartment units have air-conditioning, individual emergency alerts and security systems. The comfortably furnished lobby, community room, library and outdoor spaces offer accessible places to meet and socialize. On-site social work staff provide counseling services and plan social and recreational activities. Residents can go to the Rosenthal Senior Center across the courtyard for hot congregate lunches and a myriad of education, social, culture and volunteer programs.


The New York United Jewish Agency (UJA) Federation provided assistance to Selfhelp throughout the development process, including donating a portion of the development site. HUD's commitment of on-going rental subsidies will enable the diverse mix of tenants, reflective of New York City's wide mix of populations, to live independently and to access a wide range of opportunities for recreational, educational and social activities. This project exemplifies the best of HUD's partnership with non-profits through the Section 202 Supportive Housing Program for the Elderly.

FIRST ALL-SENIORS COMPLEX in FORT WORTH OPENS LEARNING CENTER

Fort Worth Multifamily Hub staff recently joined the property managers and residents of the Vega Place Senior Apartments August 16, in celebrating the grand opening of Fort Worth's first-ever Neighborhood Networks Learning Center in an "allseniors" housing complex. The Vega Place Neighborhood Networks Learning Center became the learning and activities center of the one-hundred-plus Section 8-assisted senior citizens living at the complex and the numerous other elderly citizens who will also participate in the activities offered at the center.

The learning center includes a computer center equipped with four stand-alone computers, two lap-top computers, a printer, a scanner and a digital camera, most of which were donated by the U.S. Department of Housing and Urban Development's (HUD) Fort Worth office. The facility also includes a clothes care center and a club room which is transformed every first and third Tuesday of the month into a grocery store for the Vega Place's Food Bank program.

What makes the opening of this learning center even more impressive is the fact that when the California Commercial Investment Company bought the facility in May of 2000, the complex was failing in most major categories of HUD's Real Estate Assessment Center (REAC) Property Inspection Process. The new owner, however, had a brighter vision for the Vega Place Senior Apartments. During the last two years, they have invested in upgrades such as new heating and air conditioning units, interior remodeling, exterior paint, new windows and landscaping. In the most recent HUD REAC inspection, Vega Place passed with flying colors.

Jainet Huling, the Vega Place Property Manager, and Tresa Echols, the Vega Place Resident Association President, have formed community partnerships to develop programs offered through the learning center. Southwood Baptist Church, for example, has partnered with Vega Place to provide volunteers to teach residents how to use the computers. Additional examples of partnerships include the Vega Place Food Bank where residents can shop free. The groceries are donated by organizations like the Tarrant County Area Food Bank and Kroger Food Stores. The Fort Worth Health Department is conducting a chronic illness management class which teaches the residents how to manage their diseases and understand their medications.

The Fort Worth HUD Office was recognized during the celebration for its leadership and assistance in making the Vega Place Neighborhood Networks Learning Center a reality. Fort Worth's Multifamily Hub Director, E. Ross

Burton, spoke on behalf of the Department. Virgle M.
Anderson, the HUD Multifamily Project Manager, and Vernon
Butler Jr., the HUD Multifamily Neighborhood Network
Program Officer were recognized at the grand opening
celebration. Special recognition was also given to the Austin
Affordable Housing Corporation, the Vega Place management
team, and Ray McCoy, Director of the Seniors Ministry of the
Southwest Baptist Church.

Policies and Procedures

HUD issues Mortgagee Letters to inform lenders of changes in Federal Housing Administration (FHA) operations, policies and procedures.

Mortgagee Letter 02-21, released on September 26, identifies and recommends the use of prudent industry practices related to due diligence in the acquisition of whole loans or loan pools. The Letter, which focuses on predatory lending, is the first in a series on prudent due diligence. Future Letters will focus on related matters such as prior servicing activity.
